For and on behalf of the Governor of Jammu & Kashmir State, sealed quotations are invited for wall paintings in Urban PHCs of Jammu Division under National Urban Health Mission (NUHM).

Terms & Conditions:

1. General scope of work shall include wall paintings in Urban PHCs in Jammu Division under National Urban Health Mission.
2. Initially, wall painting have to be undertaken in the 2 Urban PHCs of District Udhampur. Subsequently, if found suitable, upon inspection of these UPHCs, the same can be extended to other UPHCs which include 3 UPHCs in District Kathua and 12 UPHCs in District Jammu.
3. Successful bidder has to arrange all necessary materials required for execution of work.
4. Before submission of the rates, bidders are advised to make themselves fully conversant with the terms & conditions and all other relevant information so that no ambiguity may arise in these respects subsequent to the submission of the rates.
5. By submitting rates, bidders will be deemed to have satisfied themselves by actual inspection of the site and locality of the work, if so required, and that the rates quoted by them in the tender will be adequate to complete the work in all respects according to the specifications and other conditions and that they have taken into account all conditions and difficulties that may be encountered during its progress whether or not expressly provided in the notice inviting rates but necessary for the completion and maintenance of this work to the entire satisfaction of State Health Society.
6. SHS reserves to themselves the right of accepting the whole or any part of the quotation and contractor shall be bound to perform the same at his quoted rates.
7. **No escalation is payable under this contract.**
8. Rates quoted should be with respect to per Sq. Ft. area and should be Net (inclusive of all taxes)..
9. Interested bidders shall have to submit duly signed quotation, in sealed cover, in the office of Mission Director, NHM, Regional Institute of Health and Family Welfare, Near Sainik School, Nagrota, Jammu – 181221 **by 3rd June, 2017 upto**

 14. In case successful bidder backs-out of the contract without explicit consent of SHS, he will be liable to recovery at higher rates which may have to be incurred by SHS.
