Subject: 'Enhanced Compensation Scheme - 2014' for sterilization services in 11 High Focus States (Uttar Pradesh, Bihar, Madhya Pradesh, Rajasthan, Chhattisgarh, Jharkhand, Uttarakhand, Odisha, Assam, Haryana and Gujarat)

Dear

Family planning is one of the main interventions under RMNCH+A to achieve the MDG Goals. The recently computed FP2020 goals also underline the importance of performance in sterilization especially for the 11 high focus states mentioned in subject above.

The existing 'compensation scheme' in sterilisation for all the states came into effect way back on 07.09.07. In the light of the rise in cost of living, the ever increasing cost of transportation which enables a client to travel from his residence/village to the nearest service centre, the prevalent high wage compensation for the days requiring recuperation as well as other incidental costs, the Government of India has approved an enhancement in the current compensation for the above states.

The component wise breakup of the revised package as well as the detailed guidelines for the 'Enhanced Compensation Scheme - 2014' is annexed below.

Implementation of the enhanced compensation scheme in your State/UT may be initiated with immediate effect from the relevant budget head.

The general guidelines and salient features of the enhanced compensation scheme are as follows:

- 1) The funds for the increased compensation package could be utilized from the existing sterilization compensation head under A.3. The additional requirement if any under this component may be proposed in the supplementary PIP.
- 2) The states/UTs may also ensure that the compensation to the acceptors, motivators and all categories of the providers be made on the same day at the facility where procedures have taken place. The health facility should ensure conducive environment for the acceptors and enabling environment for the provider and follow the guidelines already issued in this regards
- 3) Enhancement of the package for tubectomy from Rs. 1000 to Rs. 2000 with the client receiving an amount of Rs. 1400 instead of the present Rs. 600 to compensate for loss of wages, transport, nutrition, and post-operative recovery.
- 4) Introduction of a package of Rs. 3000 for promoting post-partum sterilisation (immediately or within 7 days of delivery) so as to provide this method to the ever increasing number of women delivering in public health facilities.
- 5) Increase in the package for vasectomy from Rs. 1500 to Rs. 2700 with the client getting an amount of Rs. 2000 (to compensate for loss of wages, transport, nutrition, and post-operative recovery) instead of the present Rs. 1100 only.
- 6) The private accredited/ NGO centre package is also raised from Rs. 1500 to Rs. 3000 for both tubectomy and vasectomy. *This will include Rs. 2000 to the private facilities, Rs. 1000 to be paid to the acceptors (since this component was not being provided until now).*
- 7) Rest of the guidelines for accreditation of private providers remains same as per the revised compensation scheme 2007(No. N. 11019/2/2006-TO/Ply)
