

Terms and conditions:-

1. Contract will be offered by the Director Family Welfare, J&K and the candidates shall have to sign a contract with the Director Family Welfare , J&K as per the guideline of NHM.
2. Contractual appointee shall not be entitled to any claim for regular appointment under normal process of selection.
4. Stay of the candidate is mandatory at the place of posting.
5. Initial term of contract will be for one year which is further extendable for a period of another one year subject to the satisfactory performance of the appointee. The contract is terminable at one month's notice.
6. If a contractual appointee at any time wilfully neglects or refuses to perform his/her duties, his/her services shall immediately be terminated as per guidelines, under NHM/ procedure under rules.

7. Applications not falling in prescribed criteria shall be rejected.
8. The selected candidates shall be paid monthly honorarium under National Health Mission, as mentioned above . The contractual appointee shall not be entitled to any other allowances or monitory benefits whatsoever.
9. The last date for receipt of application forms, as prescribed above shall be the cut-off-date for determining the eligibility for applying against any post. The age limit is determinable with reference to first of January 2015.
10. A candidate found guilty of impersonation or submitting fabricated /tampered documents/testimonials or making statements which are incorrect, false or suppressing material information, may in addition to rendering liable for legal action under law, his /her candidature shall be cancelled at once.
11. Preference will be given to the candidates below the age of 40 years.
12. Candidates belonging to other Divisions need not to apply as National Health Mission stresses upon local selection criteria for each vacant position.


