- 2. Rates quoted shall be F.O.R. State Health Society, National Health Mission (Near Sanik School ), Kandoli Nagrota, Jammu 181221/ Housing Board Complex, Channpora, Srinagar.
- 3. Rates quoted shall be inclusive of all taxes and levies.
- 4. Rates quoted shall be clearly typed or handwritten and without any cutting, over writing. The rates shall be quoted in words as well as in figures also.
- 5. Each page of the rate quotation shall be duly signed by the authorize dried signatory.
- 6. Rate quotation alongwith earnest money deposit of Rs.5,000/- (Rupees Five Thousand only) in the shape of CDR/ FDR (valid for one year) from any Nationalized Bank or Jammu and Kashmir Bank Ltd duly pledged to the "FA&CAO, State Health Society, NRHM, J&K" shall reach this office by hand or by post upto 25<sup>th</sup>. Feb, 2014 (upto 3.00 PM). The same shall be opened on 28<sup>th</sup>. February, 2014 at 3.00 P.M. in presence of the bidders who wants to be present for the same.
- 7. The successful tenderer shall have to abide by the terms and conditions as mentioned in the NIT as well as in the Rate Contract for which the successful bidder shall have to execute an agreement with the State Health Society within 15 days from the date of award of contract.
- 8. The contract fixed with the successful tenderer(s) shall remain in force for a period of 12 months from the date of issuance of approved Rate Contract extendable for further three months or till the new rate contract is finalized and issued, whichever is earlier. EMD of the successful bidders shall be released after successful completion of the contract.

- 9. The supplies shall be made within three days from the date of issue of supply order. In case of any default of any nature whatsoever by the successful bidder, the State Health Society reserves the right to forfeit the EMD.
- 10. No advance payment shall be made. Payment of goods shall be made after supplies are received in the stores and verified by the verification committee of State Health Society and accepted in accordance with the approved Rate list/ supply order within the specified time.
- 11. Any loss sustained by the State Health Society as a result of re-tendering the contract or allotting the same to another bidder due to backing out or non-execution of supplies by the successful bidder shall be recoverable from the defaulting bidder out of his earnest money deposit or from his pending bills with the State Health Society, as the case may be.
- 12. In case of any dispute, decision of the Chairman, Executive Committee, State Health Society, NHM, J&K shall be final and binding on both the parties.
- 13. State Health Society reserves the right to accept or reject any tender or part of it without assigning any reasons thereof.
- 14. The State Health Society may terminate the contract at any point of time without a prior notice, in case of unsatisfactory services.
